A stable discount of 0.6x–0.8x price to tangible common equity (P/TCE) is statistically highly significant. The results suggest that the G-SIB designation effect, which positively impacts G-SIBs share prices because of funding benefits from IGGS, is dominated by the regulatory G-SIB burden effect, which negatively impacts G-SIBs share prices because of lower profitability due to capital surcharges and other regulatory requirements placed on G-SIBs. The findings re-open the debate about whether breaking up G-SIBs would unlock shareholder value and whether G-SIBs are regulated efficiently.
